MINUTES Meeting held at the Hall, TRURO

Monday 18th November at 7.30pm.

1. Welcome: Chair K Falkenberg welcomed members M Anderson, C Fox, P Holmes, A Philpott, J Schrapel, Cr. I Bormann

2. Agenda Review: No additions or changes

3. Apologies: N Voorendt, R Sherwood

Moved: M Anderson Seconded: A Philpott The apologies be received. Carried.

Members went into Pioneer Park to review design and in-place works and consider options for plantings, etc.

4. Minutes:

Moved: A Philpott **Seconded:** P Holmes The minutes of 21st October 2013 be accepted as amended. **Carried.** Amendment: Item 7.2.1 Account Balances to read: as at **21**st **Oct 2013**

5. Business Arising from Minutes:

5.1 - Elections

5.1.1: Treasurer: Chair has not met with N Voorendt but has talked to him. He is willing to serve as Treasurer.

Moved: A Philpott Seconded: M Anderson Nicolaas Voorendt be elected Treasurer. Carried.

5.1.2: Bank Signatories:

Moved: P Holmes Seconded: C Fox Bank Signatories are Chair, Treasurer and Secretary, any 2 thereof. Carried. 5.2 – Auction In discussion it was mentioned that for this event to happen we will need a Coordinator, not from the Board. M Anderson will check out Tom Palmer. A Philpott asked about holding a boot sale. M Anderson compared the proposed auction to the annual Angaston Men's Club sale, which is auctioneered. There was discussion about a local project that the auction could raise funds for.

<u>5.3 – Hall Toilets</u> someone from the Red Cross who did not know about previous arrangements complained to MMC. There were leaves and dust, but not much bird mess. Roof was lifted a little by wind, MMC will fix. Tonight's inspection showed no droppings. Red Cross has written proposing that they will clean women's toilets and the art group do men's, weekly and before hall hire. The next Red Cross meeting will be 2 Dec midday. K Falkenberg stated that we continue as is, they are welcome to do extra cleaning. M Anderson thought that if Red Cross wants to clean they should do both. K Falkenberg will speak to art class and Red Cross, may go to Red Cross meeting. We will forgo increase in fees for both.

- <u>5.6 BMX Track Plans</u> C Fox reported. Per letter from Amy Loechel of Council, plans have been approved. We have not received a copy of the plans.

- **5.8.1: Review and charges:** K Falkenberg and M Anderson will meet on this.
- **5.8.2: Security:** K Falkenberg, M Anderson and C Fox met to review hire request for Nov 18th. With this application we did not require professional security. The event went off well. A Philpott asked if we want to formulate a standard policy re security.

Next week I will collect the petitions, write a letter to the Minister, and call newspapers for a photo shoot.

7.3 Highway Bypass Mid Murray Council has asked us for a response to the new State Transport and Land Use Plan, which closes public comment on 29 November. The members directed A Philpott and C Fox to work up a draft response to circulate among the board for review prior to the 29th.

Moved: C Fox **Seconded:** A Philpott That The Truro and District Community Association, Mid Murray Council and the Department of Planning, Transportation and Infrastructure commence a planning process so that the Sturt Highway Bypass at Truro results in the enhancement of the local economy, the main street and the community. **Carried.**
