MINUTES

Meeting held Monday 22 August 2016 at 5.00pm Weighbridge Motel Dining Room

- <u>1.</u> **Welcome:** Chair K Falkenberg welcomed board members C Fox, P Holmes, J Schrapel, A Philpott and Cr B Schmitt, and guests S Fox, R Pfeiffer, and S Jarred. The meeting opened 510 pm.
- 2. Apologies: R Sherwood, C Ruth; Chair tried to get hold of B Slow to query his attendance, but didn't get through.
- 3. Agenda Review (additional items for discussion) Nil
- <u>4.</u> **Minutes:** Moved: P Holmes Seconded: Cr B Schmitt That the minutes of 18 July be accepted Carried. Business Arising:
 - S Fox reported that Truro CFS will ask about sealing road to station and in front of standpipe, and putting Emergency Vehicles Entering sign on highway.
 - C Fox wrote to Landmark and bird cages left at the rail yards will be available 1 Sept.
 - There was discussion on emergency signs for hall and oval.
 - There was discussion on the plastic dog bags at the oval, which degrade when exposed to heat.
 - History grant will not proceed.
 - A digital voice recorder has been purchased and D Shelton has been recording conversations with Scobie and Dawn Ruedeger.
 - The defibrillator has arrived. We are still working with United about putting it there.
 - A Philpott wrote to Mogas and White Wire about replacing the temporary fencing at the former Golden Grill site.
 - There was discussion re the derelict shack at the United property behind the service station, next to the car park and facing North Terrace.

5. Reports for information:

5.1 Council – Cr B Schmitt reported on the public toilets. They are cleaned daily. Maintenance is a council responsibility. Council is supposed to replace damaged or missing rubbish bins. If regular bin pickup fails, call the contractor and they will come around. There are no funds for sealing the CFS entry road. For queries re road signage email Greg Hill, works director. Extra material from Moculta road could possibly be used to seal the gravel at the water hydrant at the intersection of North Terrace and Dutton Mail Road that is used extensively by the CFS during fire season.

5.2 BMX - C Fox reported that construction will begin as soon as the site dries off after the winter rains.

5.3 Web Site – C Fox reported that all sections are up to date. He is working on creating live booking calendars and a notification mechanism so that cleaning and other maintenance duties are carried out more reliably.

- Accounts for payment. P Holmes presented an invoice received from Northland Packaging (\$95.81) for cleaning supplies received by B Anderson, Oval cleaning coordinator. Moved: P Holmes Seconded: K Falkenberg. That the accounts be paid. Carried.
- There was discussion re electronic payments. We will need to examine our Rules to make sure there are appropriate checks and balances specified for modern banking, and we may need to make a proposal for a Rules change at the AGM.
- Jo Lemmey was appointed to the board to fill the new vacancy. She has volunteered to act as Treasurer. We
 need to update bank signatories: K Falkenberg, J Schrapel and J Lemmey. C Fox will coordinate financial
 reporting with J Lemmey.

6.2 Hall and Oval -

- K Falkenberg will work on getting acoustics analysts to come up and look at Oval. S Fox reported that floor mats as discussed at the last meeting do not work as sound absorbers.
- P Holmes reported that the Red Cross Op Shop is now opening on Saturdays, with a trial run for Sept. He will
 check with the electrician bout lighting and power upgrades.

- Fireworks were set off at the Oval during a recent hire. Those responsible denied knowledge, but fireworks and lighters were left on the Oval. We need to put a specific restriction in the hire rules. (Sigh)

In open discussion, P Holmes stated that the Board can take on too much. K Falkenberg stated our focus should be on small scale volunteer efforts. Don't lose our passion.
