7.2 Chairman:

7.2.1 – Truro Projects Advisory Committee:

Pioneer Park Development:- As Stan Robb has resigned from Gilbert & Associates no further action could be taken until the new incumbent has met with K Goldstone. It is hoped that the final plan will be adopted at the next meeting at the end of May.

Truro Stormwater Management Plan:- K Goldstone advised that the consultant for the Storm Water Management Plan would be appointed shortly in consultation with the Storm Water Management Authority. They are the major providers of funding and consequently have a significant say in who will be appointed. The next meeting is scheduled for 27th May.

<u>**Truro Oval Complex:-**</u> As a result of the visit to Tungkillo by members of the committee, a final draft plan of the kitchen was sent to W Reddy for his action. Committee members asked that:

- alterations be made to the toilets to allow for a urinal in the men's toilet
- rearrangement of access to the outside facilities.

With the alterations to the inside it was considered there was sufficient room for a small store room to be included as well. The amended plans were agreed to in principle with a couple of minor suggestion for improvement; they can be forwarded to Council to obtain building and development approval.

Moorundie Street:- There will be new paving in the immediate vicinity of the Town Hall and Post Office sometime after the end of the financial year. A Strauss has advised that Council would use concrete pavers. Feltus Paving has been asked to submit a quote. Pram ramps may be installed on Passenger and Cross Street sooner. Primary Industries from Freeling has indicated that they could do a plan of trees for the main street and provide recommendations for suitable species. This might be available at the 27th May meeting.

G Sweeney advised that Barossa Olives would like to get an ash tree removed. Letters have been submitted to council. It was resolved that the Association will take copies of the letters from Barossa Olives to the May 27th meeting where trees will be discussed.

<u>Mayor's Party</u> – About 50 members of the community attended the Mayor's Party at the Town Hall on Tuesday 12th of May.

7.3 Secretary: The Roses planted by the Association on the north side of the cemetery fence are not growing well; the south side bushes are doing better. There have been problems in the past with local interference with the watering program.

<u>7.4 Oval</u>: - M Anderson reported that attendance at meeting has been sparse and he is looking for suggestions as to the immediate future of the subcommittee.

<u>7.5 Hall:</u> - There has been no subcommittee meeting and none is scheduled. Holes in the Hall back door have been patched roughly. Paint does not match. K Falkenberg will follow up with window repairs.

There has been an increase in illegal motorcycle riding in town. Council and Police have been made aware that riders have been causing damage in a number of places.

Speeding on North Terrace is still an issue, and dangerous with bike riders. Information from road count on North Terrace will be available by next meeting. We hope that Council make an application to Transport SA to downgrade the east end of North Terrace per our request.

7.6 Council: - Cr. R Schultz was unable to report. There are fears that road works are likely to be cut in the next council budget.

7.6 Web Site: - C Fox reported on the current status. See Business Arising from Minutes.**Moved:** K Falkenberg**Seconded:**G SweeneyThat the reports be received. Carried.

8. General Business:

<u>8.1 – Board vacancy -</u> See Business Arising from Minutes.

8.2 – Fund raising Co-ordinator/ Subcommittee- M Anderson reported. A lot is starting to happen around town; council is putting in money, and grants have been obtained, a total of over \$200,000. The town population has not done any fund raising. There is a need for people to put something back into the community. There was a local fund raising committee in years past. Now is the time to get a new one going. The Association can steer volunteer efforts? Collected funds can be dispersed to clubs and organizations, with a reserve to hold for local projects. We can aim to get the whole town involved. In 2011 the Primary School will have a 25 anniversary celebration with the opening of a time capsule that was place at the State's 150th Celebrations. This will be a big event locally. It is now time to and come up with some ideas to bring people together.

<u>8.3 – Tree Planting Co-ordinator</u> – There was a call for a small sub-committee to organise this year's planting. Association members have been raising seedlings. The subcommittee will start with an inventory and plan some events.


<u>8.4 – AGM:-</u> The date was set for the 25th August. We will take the web site live and report on ongoing projects.
