- 3. Business Arising from Minutes
 - **3.1 Centrelink** Kristin met with Centrelink staff to progress the Op Shop becoming a Volunteer Work Verified Location matter is pending.

- **4.1 Council** Andrew Young addressed the meeting to find out the procedure for asking Council to seal Quarry Road, 1st St and 2nd St. Greg Hill (MMC) spoke about the ongoing road sealing program in MMC with 127kms of town roads still unsealed. Greg reiterated about the priority for council is sealing higher priority roads such as collector roads. Greg mentioned that the Dutton Bridge upgrade was progressing and is at the detailed design and tender stage. The street trees for the Moorundie Street are currently at Kristin's place awaiting planting.
- **4.2 Tony Pasin** (Member for Barker) spoke about the challenges of councils such as Mid Murray which have a large area but small population. The Federal Government priority for this region is the road network.
- **4.2 Chair** Kristin reported that Mayor Dave Burgess is hosting a volunteer acknowledgement evening at the Truro Oval on the 27^{th} March from 6.30 7.30.
