# MINUTES 18<sup>th</sup> April 2024 at 19:00pm at the Truro Oval

Business Arising from Minutes: Discussed below:

### **Chairperson Report:**

Once again, thank you to all members of our community who have posted on Facebook, contacted the RAA and SAPN, canvassed the Mid Murray Council and our politicians regarding the installation of an EV Charging station in Pioneer Park. The transformer has been removed and a meeting was held earlier this evening between MMC, RAA, TDCA board and community members. MMC and RAA apologise to the Truro Community for the distress this has caused. A PowerPoint presentation was conducted outlining the EV Charging station process. Three options to rectify the situation are on offer:

- 1. Relocate the transformer to the northern carpark (opposite the Bakery) \$290k
- 2. Relocate the transformer back 19m in Pioneer Park \$70k
- 3. Relocate the transformer to the rear of Pioneer Park \$175k

TDCA need to consider the next steps in this process and let the MCC know how we want to proceed which we will discuss at tonight's meeting.

The safety rail leading to the public toilets was replaced prior to the Easter long weekend.

An apology from last meeting's chair report regarding the letter which was emailed to DIT and our elected members regarding the safety and maintenance of Moorundie Street. A positive response was received from Ashton Hurn MP: "I appreciate and share concerns about the scrapping of the funding for the freight route by the Labor Government, and also the condition of the road and safety more broadly. As the local MP I have raised road safety concerns and the condition of the Main Street with the relevant State Ministers, and even invited the State Minister to join me in Truro. He is yet to take me up on that offer, and I know Tony Pasin has invited the Federal Infrastructure Minister too. I'll continue to work with the community and pursue these issues."

The Truro Freight Route Working Group meeting which was rescheduled for Thursday 04/04/24 was postponed. This meeting was held this afternoon.

- Truro Freight route is a required element of the Greater Adelaide Freight Route project.
- We need to create one campaign rather than three smaller campaigns.
- Tony Pasin's office can help with the design of promotional materials but this is not a political campaign.
- The working party needs to be led by community participants, therefore it was suggested that the TDCA call and lead the next meeting.
- Meetings to be held monthly, online and possibly at the Barossa Council due to poor internet access within the Truro township.

- Local governments may be asked to invest financial support for the campaign.
- The working party needs to reach out to:
  - o City Mayors along the Greater Adelaide Freight Route
  - o Freight Council
  - o Principals of schools along the Greater Adelaide Freight Route
  - o Other progress associations
- RAA is supportive of the freight route

Andrew has applied for the Telstra Connected Communities Grant to provide technology for the oval and hall. Other grants which are available:

- 80<sup>th</sup> Anniversary of the End of WWII grant closes on 30 June 2024 for an event to be held in 2025. This may be an opportunity to develop a project with the Memorial window from the Uniting Church and to record the citizens who served in WWII.
- Mid Murray Council Community Grants which will open on 1<sup>st</sup> May. The link is available on the MMC website and applications close on 15 June at 5pm.

On Thursday 11/04/24 several members of the TCDA board along with Andrew Young met with Mayor Simone Bailey MMC and Mayor Bim Lange, The Barossa Council, to explore the possibility of Truro and Dutton moving to The Barossa Council. Thanks to Chris for compiling the list of items which was emailed along with the 'Town Plan'. Chris spoke to the list he had compiled which is based on the town plan strategy. Constructive discussion transpired. If boundary relocation is to occur, we require a business case along with the signatures of 10% of the rate payers to be sent to the Boundaries Commission, MMC and The Barossa Council. The Boundaries Commission would take over the operation / process of the realignment. This could be a catalyst for the commission to look at boundaries across the state. Sedan and Cambrai need to be considered. Minutes are available from this meeting for those who would like a copy. The next meeting will be held on 2<sup>nd</sup> May at the Truro Oval at 5:30pm. Please speak with members of our community to determine the level of interest.

## **Council Report:**

Cr. Jen reported:

By law 7 has been endorsed by Council, which allows for the development of camping in the oval precinct.

Council is keen to get feedback on the cemetery improvements. TDCA is waiting on the outcome of a recent grant application so this matter can be progressed.
