- On Tuesday 3rd December, Ron and I represented the TDCA at the Mayor's Reception for Volunteers at Tungkillo.
- On Wednesday 4th December Andrew and I had an online meeting with three members of RES Australia who are the developers of The Twin Creek Wind Farm and Energy Storage. RES are committed to supporting the regional communities that host the renewable energy projects. They are reaching out to Local Councils, project neighbours, community groups and businesses to discuss and design a shared benefit program that meets community needs. The community benefit program would operate for the life of the project post construction, estimated to be 30 years. This provides an opportunity for discussions about strategic benefits that may assist the community over that extended time period. Chris supplied them with our town plan prior to the meeting. They will pull together some options for the benefit sharing program.
- On Saturday 7th December, Wendy arranged the Truro Community Christmas Gathering Outdoor Movie Night. Thank you, Wendy, for organising this event.
- There hasn't been an update from the Boundaries Commission meeting held on 20 November 2024 regarding the Council Boundary Realignment for the Truro District.
- As I've reported at previous meetings, there haven't been any further meetings of the Truro Freight Route Working Group since April '24. The SA government is implementing a 'Transport Strategy'. I attended the information session at Barossa Central on Monday 26th November. It was a Virtual Reality modelling of towns or cities based on your responses to options provided. More information is available on the link transportstrategy.sa.gov.au. Responses to the Strategy close on 16th December.
- Andrew has been liaising with Andy Glen, Tourism Manager MMC and Rhiannon Seres Tourism and Heritage Assistant – Morgan regarding Truro's presence on the MMC tourism website and app. Thanks Andrew for following up.
